

Information clause on the Ferrovial Juntos COVID-19 programme

FERROVIAL CORPORACIÓN, S.A. (hereinafter, Ferrovial) will carry out the activity of registering and communicating the donors' data to the NGOs that will be the end receiver of the donated funds so that they can issue, on behalf of the donor, the corresponding certificate to be able to apply the applicable tax deduction, with the following conditions:

How the Programme works

The purpose of the Programme is to donate funds to an account, designated for this purpose by Ferrovial, to be able to allocate it to various recipients to help alleviate the effects of the situation caused by the COVID-19 crisis, including: (i) The provision of medical equipment, and (ii) contribution to social aid NGOs for vulnerable groups affected by this situation, and (iii) contributions to vaccine or treatment research centres for COVID-19, within the framework of a joint donation project between donors and Ferrovial, who will double the funds contributed by each donor up to a limit of 10 million euros (hereinafter the Programme).

What Data can be processed?

The data that can be processed are the identifying and tax data required to carry out the donation of the Programme as well as issuing the necessary certificate to be able to apply the corresponding tax deduction.

For what purposes do we process your personal data?

We will process your data to be able to carry out the donation for the Programme. We will also process your data to communicate it to the entity receiving the donated funds so that it can issue the certificate required to apply the relevant tax deduction.

What is Ferrovial's legitimacy for processing your data?

The basis for processing your personal data lies in your consent as well as in maintaining the legal relationship established as a result of your participation in the Programme through your donation.

Who will your data be communicated to?

The data will be communicated, with the consent of the interested party, to the entities receiving the donation so that they can issue, in the name of the donor, the corresponding certificate proving any applicable tax deduction, where appropriate.

In addition, the data may be transferred to the law enforcement bodies, Courts and Tribunals, as well as any other assignment resulting from the fulfilment of a legal obligation to public administrations, fight against fraud, etc.

How long do we keep your data?

The data will be kept for the periods during which legal actions may be taken in relation to the donation derived from your participation in the Programme.

What are your rights in relation to our processing of your data?
