- Ensure effective communication, with requisite feedback provided as required.
- Treat each other fairly and equitably.
- Define our Supply chain for core trades and disciplines.
- Facilitate the early involvement of our Supply Chain partners in order to prove ‘best value’ solutions.
- Provide an escalation process in order to facilitate effective communication and dialogue at all levels.
- Promote 360deg reviews of project performance, jointly implementing improvement plans as required.
- Engage with our supply chain to agree fair commercial and payment terms, in line with National initiatives that flow down through Tiers two, three and four of the supply chain.
- Strive to maintain Ferrovial’s position as one of the World’s top three companies for sustainability as verified by Dow Jones.
- Work with our Supply Chain to support our PAS2080 (Managing Carbon in Infrastructure projects) compliance.
- Continue to be a partner to the Supply Chain sustainability School encouraging our Contractors and Suppliers to maintain, at least, silver level accreditation when working with Ferrovial UK & I.
- Meet, with our Supply Chain’s support, our Client’s Carbon reduction, Sustainability, Environmental and Social value requirements.
- Promote investment in training with our Supply Chain.
- Continue to support local communities, with employment opportunities, ensuring that we leave a lasting legacy by generating social value.
- Ensure that our Procurement procedures are both fit for purpose and compliant with current legislation.
- Continue to champion Innovation via relentless collaboration with our supply chain, at all tiers.
- Provide opportunities to SME, Micro, BAME & under-represented business either directly or via our Supply Chain, hosting meet the buyer events as appropriate.
- Adopt the Build UK Common Assessment standard for the prequalification of our contractors and consultants.
