

**FERROVIAL SE ("FERROVIAL" OR THE "COMPANY") ANNOUNCES TRANSACTIONS  
IN OWN SHARES**

**Amsterdam, 16 January 2024.**

Ferrovial (Ticker: "FER") refers to the announcement disclosed to the market on 30 November 2023 regarding the implementation of a buy-back program for its own shares to reduce the Company's share capital (the "**Program**").

Pursuant to articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052, of 8 March 2016, supplementing Regulation (EU) No 596/2014, of the European Parliament and of the Council, with regard to regulatory technical standards for the conditions applicable to buy-back programs and stabilisation measures, it is reported that during the period between 9 and 15 January 2024 Ferrovial has carried out the following transactions over its own shares under the Program.
